Promoting RIS3:

Central Macedonia's One Stop Liaison Office (OSLO)

The RIS3 One Stop Liaison Office (OSLO) is an initiative to support the Region of Central Macedonia's Innovation and Entrepreneurship Ecosystem and the design, monitoring, evaluation, and support in the implementation of its Smart Specialization Strategy. The office provides a structure of mediation and networking between the academic and research institutes with the business community, mapping business needs in the priority areas of the RIS3 Strategy and then organizing targeted actions to address them. Thus, OSLO supports investment and entrepreneurship by linking research, innovation and new technologies produced in the universities and research centers of the region with the real economy.

OSLO also provides information to SMES and entrepreneurs about calls and funding tools, and it operates under the supervision of the Department of Innovation Support of RCM.

CREATION OF OSLO

The initial RIS3 of the Region of Central Macedonia (RCM) was launched in 2015 based on general data entrepreneurial discovery workshops. The need for a unit to collect data, conduct primary/secondary research and implement the entrepreneurial discovery process was identified. In 2018, RCM submitted the proposal "Mechanism to support Innovation and entrepreneurship-One Stop Liaison Office (OSLO)", which was approved and funded with a budget of almost one million euros from the European Regional Development Fund (ERDF), until 12/9/2023. New funding from the ERDF has been approved until 30/9/2029 with a budget of approximately two million euros.

Implementation of promotional actions through informative workshops, press releases etc.

One Stop Liaison Office also supports open innovation and connecting ecosystem stakeholders. In this regard, it just launched the "Innovation for Society Awards", a new initiative promoting the importance of Research & Innovation in solving citizens' needs. After a consultation period to define a social innovation challenge, the solutions from start-ups, companies or individuals will be evaluated and awarded 30,000 euros.
